


When to use FloorBed™?




If the user:

REDUCING FALLS

Tom's Story

He has very poor insight into his level of function and poor risk awareness. When using a conventional low bed of 20cm, Tom experiences frequent and vivid hallucinations and appears fearful of falling from an aeroplane or a boat. Despite these hallucinations, Tom would still attempt to get out of bed at inappropriate times resulting in bed falls. Even with the use of a crash mat, these falls caused bruising, head injuries and other injuries.

Following FloorBed™ Provision:

Since having the bed, Tom has not attempted to get out of bed at all and so has not had any bed falls. In addition, it was reported that Tom has been a lot calmer throughout the day and night and has fewer and less intense hallucinations; Tom's wife believes that Tom feels a lot safer and more secure when left alone which has led to him being more relaxed and calm.

Following FloorBed™ Provision:

The FloorBed™ was provided and although Ethel continued to fall out of bed, this was now a roll rather than a fall. It was also decided to create an extension of the bed by placing a standard height mattress next to the FloorBed™, reducing the likelihood of injury even further. The benefit of the mattress on the floor was that when Ethel rolled out of bed she rolled onto an equally soft and padded surface. Another significant benefit was that the transfer back into bed was very quick and easy as the carers could use sliding sheets, eliminating the need for a hoist or other lifting system.
