Annex 2 to EU Declaration of Conformity

Intended purpose of the product family "Rehadapt table mounts"

Description

Mounts to place assistive technology devices, switches or consumer electronics on top or clamped to tables and other surfaces.

Intended purpose

Rehadapt **table mounts** are mounting systems that are either self-standing on a table top (table stand) or semi-permanently attached to it (table clamp). They serve the purpose of holding adaptive technology devices in position for use.

While connecting to the payload device with an interface that allows for quick detachment of the piece of adaptive technology, the table mount allows flexibly for precise positioning of the device, to ensure the user's operation of the device in spite of possible motor impairments or specific device requirements. The quick connection interface mates with a semi-permanently fixated device attachment plate or spigot by Rehadapt or the device manufacturer.

Rehadapt table mounts are not life-sustaining nor life-supporting and can be used either indoors or outdoors.

All necessary technical specifications (including dimensions and load capacity) are included in the respective assembly instructions and product description.

Indication(s)

Persons who rely on adaptive technology to communicate (AAC), access ICT, or operate environmental control units.

Contraindication(s)

none

Intended patient group

Patients with hereditary, congenital, degenerative or acquired movement disorders, specifically in conjunction with limitations in communication; or patients with limitations in verbal speech.

Conditions include, but are not limited to:

- Cerebral Palsy
- Neuromuscular diseases such as ALS, SMA, or MS
- Acquired Brain Injuries such as Stroke, TBI or aneurysms
- Rett or Angelman syndrome, or other severe multiple disabilities
- Autism Spectrum Disorders

Intended users

Rehadapt products are intended to be installed by a qualified distributor and to be operated by the care personal of the patient (family, caregiver, teacher, therapist, nursing staff, etc.). In some cases, it might be operated by the patients themselves if they possess sufficient motor control to do so.
